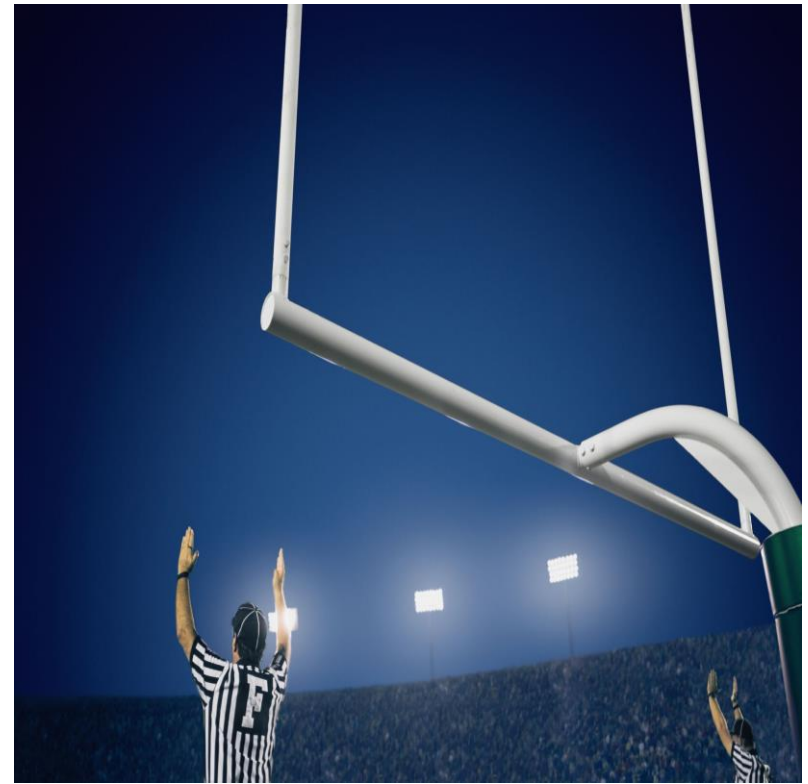

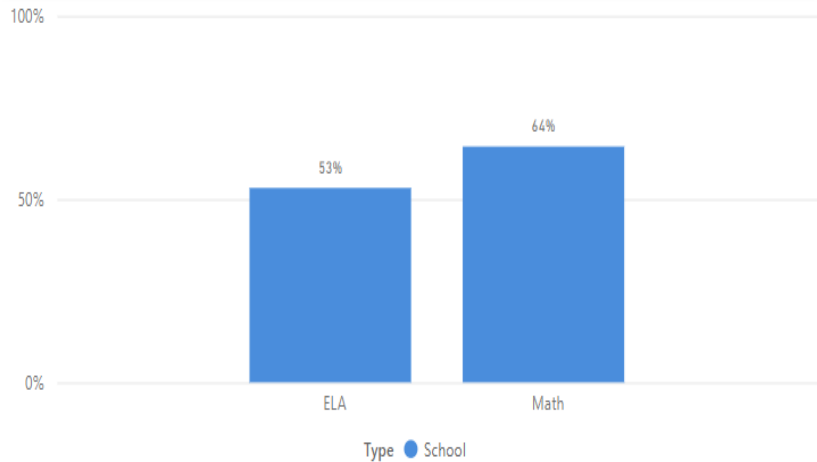

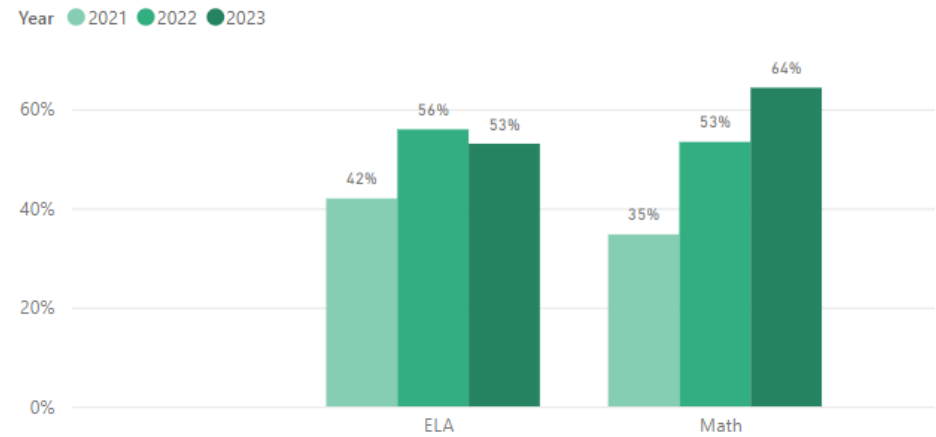

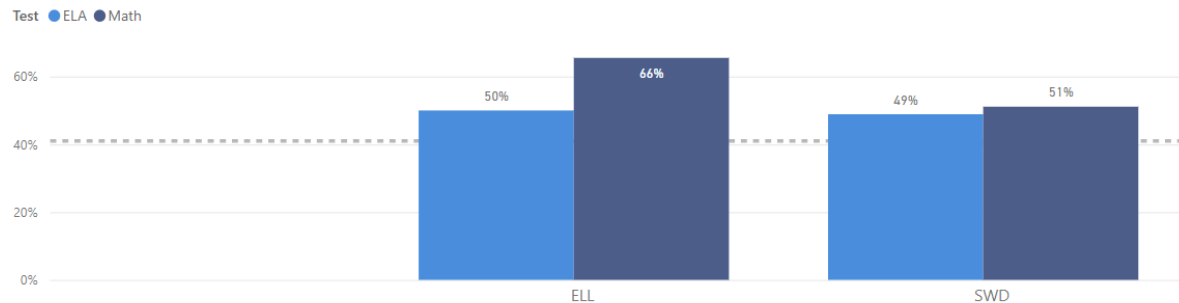
2023 FAST/EOC Proficiency - District/Tiered Comparison

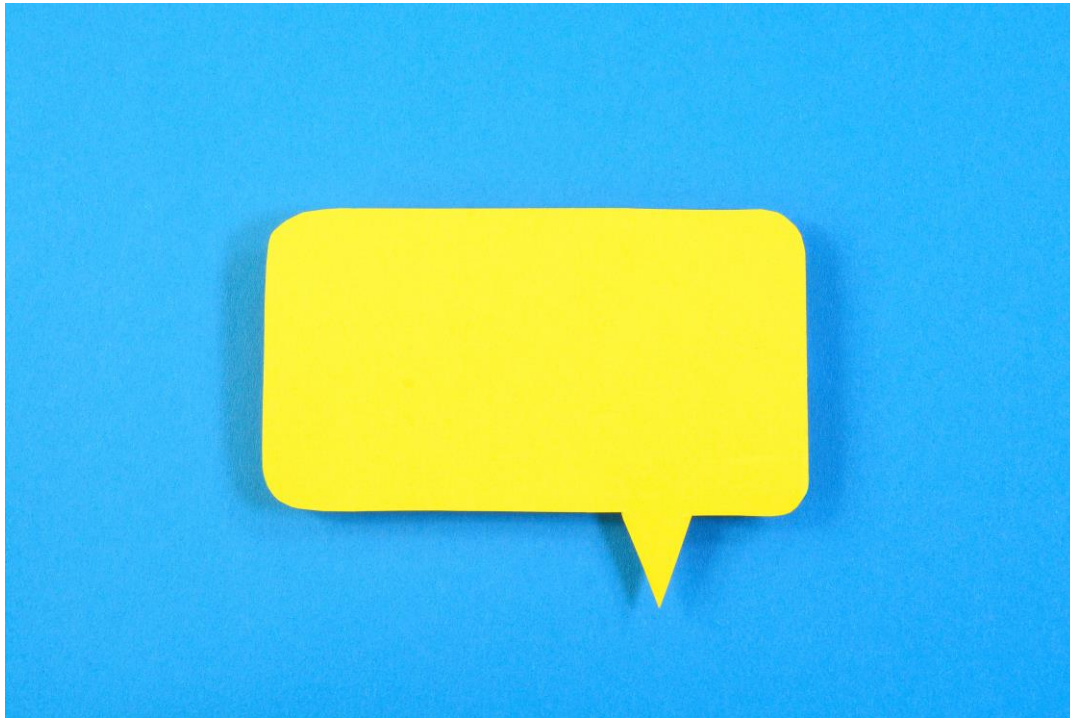
